It is understood that cruise or land excursions are provided by independent contractors and that *Starshine Travel, Inc.* has no privity with or control over the business, operation, equipment or personnel of such independent contractors. It is understood that *Starshine Travel, Inc.* shall not be held responsible for breach of contract or any negligent or intentional actions or omissions on the part of any travel suppliers or independent contractors which may result in loss, damage, delay, injury, or death to customer, travel companions or group members. Customer agrees to look only to those directly responsible for redress of any damage or injury.

It is agreed that *Starshine Travel, Inc.* shall not be responsible for any injuries, deaths, losses, damages or delays caused to any customer in connection with social or labor unrest, terrorist activities, mechanical or construction difficulties, financial insolvency of any travel suppliers, diseases, viruses, illnesses, local laws, climatic conditions, abnormal conditions, or any other reasons outside the direct control of *Starshine Travel, Inc.*

To the extent permitted by law, customer expressly releases *Starshine Travel, Inc.*, its owners, employees, agents, officers, directors, associates and affiliates from any claim or liability arising out of customer's participation in the cruise and related travel and expressly agrees to indemnify, hold harmless, and defend *Starshine Travel, Inc.* from all liability, claims, actions, suits, and demands of any kind arising out of customer's participation in the cruise and related travel.

*Starshine Travel, Inc.* advises that travel, baggage, cancellation, medical, accidental death and other insurance is available at reasonable rates to cover risks associated with the cruise and related travel. Customers are advised to review their existing insurance policies for coverage and to obtain additional insurance deemed necessary.
