Travel Documentation Requirements

U.S. airports require that all passengers over the age of 18 present a valid photo ID, which MUST be issued by a local, state of federal government agency (i.e. driver's license, military ID card). Children under the age of 18 must be accompanied by a parent or legal guardian. It is strongly advised, and at some airports necessary, for the parent or legal guardian to have a certified copy of the minor's birth certificate. Single parents traveling with a child under the age of 18 may be required to present a notarized letter signed by the minor's non-traveling parent granting permission for the trip. A valid passport is required to enter the United States from the Western Hemisphere and abroad, including Canada, Mexico, Bermuda and the Caribbean.

Cruise ship passengers must also travel with a valid passport, except that passengers traveling aboard domestic "closed loop" cruises (sailings originating and ending in the same U.S. port) who are U.S. citizens may present a valid passport or a certified copy of their birth certificate and a photo ID issued by a local, state or federal government (i.e. driver's license or military ID card). However, since a passport is required to fly into the U.S. from most cruise ship ports of call, we strongly recommend that you travel with a valid passport in case you need to fly home in an emergency. Non U.S. citizens must have a valid passport with a multiple re-entry visa or a valid green card and photo ID issued by a local, state, or federal government (i.e. driver's license or military ID card). Some non-U.S. ports of call may require visas as well. Single parents traveling with a child under the age of 18 may be required to present a notarized letter signed by the minor's other parent granting permission for the trip. It is strongly advised, and required by most cruise lines, for the parent or legal guardian of a minor under the age of 18 to have a certified copy of the minor's birth certificate. No passenger under the age of 21 may sail aboard a cruise ship unless accompanied by a parent or legal guardian over the age of 25. Passengers who fail to present proper ID and proof of age will be denied boarding of the vessel and no refund will be given.

These are only some of the travel regulations being enforced at the present time. Regulations may change from time to time and it is therefore the *passenger's sole responsibility* to make sure that he or she is in compliance with all travel, immigration and customs regulations. *Starshine Travel, Inc. has prepared this document for you as a courtesy only, and expressly disclaims any responsibility for its accuracy.
